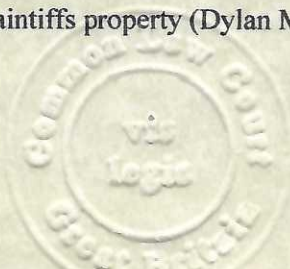

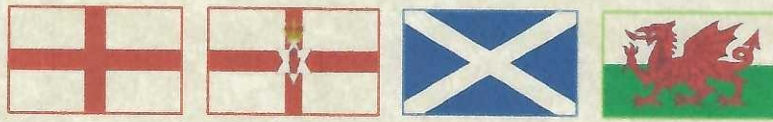
1. Their Fraudulent use of the statutory system and courts to target the Plaintiff.

It is hereby ordered that after a unanimous decision of the court, that all previous decisions issued against the Plaintiff regarding the removal of the child (Dylan Milazzo) by the statutory courts, have now been annulled.

It is further ordered that the property referred to (Dylan Milazzo) has to be restored to the Plaintiff within twenty-four (24) hours, after the signed receipt of this order.

It is further ordered that each of the Defendants are liable in their personal and private capacity for a financial penalty of £1.00 per minute (payable to the Plaintiff), until such time as the property (Dylan Milazzo) is returned to the Plaintiff.

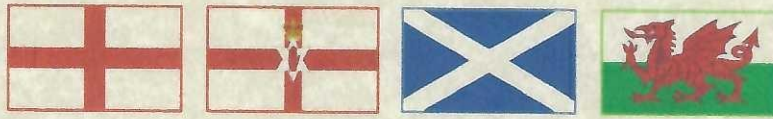
It is further ordered that the Defendants are each liable for a financial penalty of £10,000, this sum has been determined by the jury and will be payable to the Plaintiff within a period of fourteen (14) days from the signed receipt of this order.

It is further ordered that the man or woman acting as the Chief Executive Officer for the Scottish Children's Reporters Administration, is required to forward the following information to the Plaintiff within seven (7) days from the receipt of this order, this information to be sent by recorded delivery;

1. A copy of the Business Charter for Scottish Children's Reporters Administration.
2. A copy of the Mission Statement for Scottish Children's Reporters Administration.
3. A copy of the registered business details for the Scottish Children's Reporters Administration, to include registered address, Directors and Company Registered Number.
4. A copy of their liability insurance details to assist with a further claim, should the Plaintiffs property (Dylan Milazzo) not be returned.

In the event that these orders are not complied with, the Common Law Court will take further action against the individuals concerned, to enforce its decisions.

These Court Orders are effective as of this date and will remain in force until such time as they have been enforced. These orders are issued under the authority of this Common Law Court and jus gentium, the Law of Nations.
