Any reference in this legal document to “we”, “our”, “us”, refers to the living man, **NAME ONE HERE**, and the living woman, **NAME TWO HERE**. Note we are not a defendant, respondent, person, occupier or resident and do not live in a dwelling.

In future correspondence, please do not use any titles to address us, including “MR” and “MRS” etc. We do not hold any such titles. We are a living man, and a living woman, and neither are, nor operate as a dead fiction.

Common Law Court registration numbers FN / **00** / **00000** & FN / **00** / **00000** confirm we own the fictitious/legal entity names, **ALL CAPITAL NAME 1 HERE** & **ALL CAPITAL NAME 2 HERE**. You are informed that all meanings in this, and of our communications are taken from the Oxford English Dictionary, not to be confused with legalese, nor any other language of any secret society, including the Law Society, the Bar, the Royal Courts of Justice, Courts of England and Wales, Freemasons, or any foreign language. We are a living man and living woman speaking simple English and not to be taken in any other way or meaning.
