Preamble

This Notice is a contractual offer made under English Common Law. It applies to all corporations, government bodies, enforcement officers, security personnel, agents, employees, and contractors (hereafter “Parties”) who engage with me, my property, or my private affairs.

By engaging in any of the activities listed herein, the Parties agree to be bound by the fees and conditions below.

This Notice is supported by Common Law, the Bill of Rights 1689, and statutory law including but not limited to the Human Rights Act 1998, the Protection from Harassment Act 1997, the Criminal Law Act 1977, and the Torts (Interference with Goods) Act 1977.

Notice to Agent is Notice to Principal. Notice to Principal is Notice to Agent.

Terms and Fee Schedule

1. **Denial of Due Process** – £1,000,000 per denial of due process or jury trial.
(*Human Rights Act 1998, Art. 6*)
2. **Enforcement Collection** – Actual costs per private enforcement company. Debts above £1,500 subject to 8.5% interest.
3. **Harassment** – £1,000 per act.
(*Malicious Communications Act 1988; Protection from Harassment Act 1997*)
4. **Kidnap / Unlawful Arrest** – £5,000 per person per day.
(*Criminal Law Act 1977, s.6; HRA 1998, Art. 3 & 5*)
5. **Libel / Defamation / Extortion** – £10,000 per act.
(*Defamation Act 2013; Fraud Act 2006*)
6. **Permanent Injury / Disfigurement** – £1,000,000 per unlawful or unprovoked injury.
7. **Physical / Psychological Harm** – £20,000 per individual harmed.
(*Offences Against the Person Act 1861*)
8. **Seizure of Goods** – £1,250 per day until goods are returned.
(*Torts (Interference with Goods) Act 1977; Theft Act 1968*)
9. **SIA-Licensed Security Attendance** – £250 per attendance.
(*Private Security Industry Act 2001*)

10. **Supply of Harmful Water** – £450 charge per calendar month for post-delivery treatment, as set out in a binding agreement by acquiescence. This is in accordance with the duty under the Water Industry Act 1991, Section 68 (requirements for water to be wholesome) and Section 70 (offence of supplying water unfit for human consumption).
11. **Trademark / Copyright Infringement** – £500 per infringement.
(*Copyright, Designs and Patents Act 1988*)
12. **Trespass** – £9,950 per act.
(*Criminal Justice and Public Order Act 1994, s.61(4)*)
13. **Unauthorised Use of Legal Fiction Name** – £500 per unauthorised use.
14. **Unlawful Stop / Interference / Detention** – £500 per hour per individual. Litigation costs: £10,000 per hour.
(*Human Rights Act 1998, Art. 5 & 8*)
15. **Unsolicited Telephone / Email Contact** – £50 per attempt.
16. **Unverified Claims in Writing** – £500 per claim.
17. **Unwanted Letters / Documents** – £500 per item sent.

Agreement

By engaging in any of the above actions, the Parties agree to be bound by this contract and liable for the fees set forth herein.

Invoices are payable within **30 days** of issue. Failure to pay will result in recovery action, including but not limited to civil claim in the County Court, with additional costs and statutory interest applied.
